HOT 97.1 "TEXT TO WIN APPLE WATCH" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WBHT-FM ("Station"), 600 Baltimore Drive, Wilkes-Barre, PA 18702, during available business hours Monday through Friday, on the Station website www.hot971radio.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **HOT 97.1's "Text to Win Apple Watch"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. - 2. **Contest Period.** The Contest entry period will begin at **8:00am ET on Monday, October 28, 2024** and will **run** through **11:59pm ET on Friday, November 1, 2024** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There is one (1) way to enter:
 - <u>Text</u>: Send a text message with the daily keyword (Monday: TIME; Tuesday: APPLE; Wednesday: WATCH; Thursday: FALL; Friday: SLEEP) spelled correctly to 1-844-971-4971 during the Contest Period. All entries must be received by 11:59pm ET on Friday, November 1, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.
- 4. **Winner Selection.** On or about 11:00am ET on Monday, November 4, 2024, Station will select ONE (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period to win a prize. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
