HOT 97.1'S "WIN KENDRICK LAMAR TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the **HOT 97.1's "Win Kendrick Lamar Tickets"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the last **90 days**, and whose immediate family members or household members have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the Station in the last **30 days** or a prize valued at \$500 or more in the Station in the last **30 days** or a prize valued at \$500 or more in the **90 days**. **Void where prohibited by law.** Employees of Station, **Cumulus Radio LLC**, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - Contest Period. The Contest entry period will begin at 2:00pm ET on Monday, December 9, 2024 and will run weekdays from 2:00pm ET through 7:00pm ET through 7:00pm ET on Friday, December 13, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win. Listen to the Station during the Contest Period. Between 2:00pm ET and 7:00pm ET each weekday (each, a "Selection Day"), when the Station plays sounder (each, the "Sounder"), listeners must call the Station at 1-844-971-4971. Caller NINE (9) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules and will qualify for the GRAND PRIZE. All entries may be played on the air. On or about 5:30pm ET on Friday, December 13, 2024, Station will select ONE (1) GRAND PRIZE winner in a random drawing from all valid qualifying entries received by each Station during the Contest Period. GRAND PRIZE winner will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize. Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest

on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE PRIZE PER PERSON.**

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 4. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. Grand Prize. ONE (1) Grand Prize will be awarded in this contest. One grand prize winner will receive:

a) ONE (1) upgrade to PIT tickets for *Kendrick Lamar* at Hersheypark Stadium on June 16, 2025.

The approximate retail value ("ARV") of each grand prize is **ONE HUNDRED DOLLARS** (\$100). **TOTAL ARV OF ALL CONTEST GRAND PRIZES IS: ONE HUNDRED Dollars** (\$100).

Station and any Sponsors make no representation or warranty about the safety of any prize. - 6. Entry Conditions and Release. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
